Section 2. Purpose. The purpose of the appropriation in Section 1 is to procure consulting and supportive services for the JSEB Program in accordance with Sections 126.608 and 126.609, Ordinance Code. Specifically, these funds will be used to competitively procure the professional services of consultants to oversee and manage the Access to Capital and Bond Enhancement programs administered as part of the City's JSEB Program.

Section 3. Carryover. The funds appropriated in this Ordinance shall not lapse but shall carryover to fiscal year 2021-2022.
