ORDINANCE 2021-717

AN ORDINANCE APPROPRIATING \$125,000.00 FROM THE TRAIL RIDGE LANDFILL MITIGATION FUND (\$25,000)TO NORMANDY ATHLETIC ASSOCIATION, \$25,000 TO MARIETTA BULLSBAY ATHLETIC ASSOCIATION INC., \$25,000 TO ARGYLE ATHLETIC ASSOCIATION, \$25,000 TO WHITEHOUSE CIVIC ASSOCIATION, AND \$25,000 TO ARGYLE FOREST YOUTH SPORTS ASSOCIATION) PROVIDE FUNDING TO BE USED FOR THE PURCHASE OF NEW EQUIPMENT AND UNIFORMS FOR SPORTS PROGRAMMING OR REPAIR AND RENOVATION OF EXISTING EQUIPMENT; PROVIDING FOR OVERSIGHT BY THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT AND DISBURSEMENT OF FUNDS UPON INVOICES/ COMPLYING WITH BIDDING PROVISIONS OF CHAPTER 126. ORDINANCE CODE/REVERTER OF ANY UNSPENT FUNDS; INVOKING THE EXCEPTION OF 126.107(G) (EXEMPTIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO DIRECT CONTRACT WITH ATHLETIC ASSOCIATIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2021-2022 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation. The funding above is an appropriation from the Trail Ridge Mitigation Fund (43301) to be spent on new equipment and uniforms for sports programming or repairs and renovations of existing equipment for various athletic associations within Council District 12 in the amount of \$25,000 each for Normandy Athletic Association, Marietta Bullsbay Athletic Association Inc., Argyle Athletic Association, Whitehouse Civic Association, and Argyle Forest Youth Sports Association.

Section 2. Purpose and use of funds. The purpose of this appropriation above is to provide funding from the Trail Ridge Landfill Mitigation Account to Normandy Athletic Association, Marietta Bullsbay Athletic Association Inc., Argyle Athletic Association, Whitehouse Civic Association, and Argyle Forest Youth Sports Association (collectively the "Associations") in the amount of \$125,000.00, with up to \$25,000.00 allocated to each Association. The funding may be used by Associations only for the purchase of new equipment and uniforms for youth sports programming or repair and renovation of existing equipment. Capital equipment purchased by the Associations pursuant to this Ordinance shall become property owned by the City and shall be inventoried by the Parks, Recreation and Community Services Department.

Section 3. Oversight/Disbursement of Funds upon Invoice/
Following provisions of Chapter 126, Ordinance Code, as to Payment
to Vendors/Reverter. The Mayor is requested to appoint the Parks,
Recreation and Community Services Department (the "Department") to

oversee the disbursement of funds. Funds may be disbursed as provided for herein upon receipt of documentation for any expenditure consistent with Section 2 above and incurred between January 1, 2021 and September 30, 2022. Funds paid directly to each Association identified in Section 4 below shall be disbursed up to \$25,000.00 only after an invoice along with sufficient proof of payment, as verified by the Director of the Department, for the listed items in Section 2 have been delivered to the Department. If a quote from a vendor is provided by one of the Associations to the Department instead of direct reimbursement for payment, the Department shall follow its ordinary procurement procedures and bid out the materials or services requested consistent with Chapter 126, Ordinance Code. Any funds not utilized for the purposes set forth in this ordinance shall be returned to the fund of origin by September 30, 2022.

Section 4. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to reimburse Normandy Athletic Association, Marietta Bullsbay Athletic Association Inc., Argyle Athletic Association, Whitehouse Civic Association, and Argyle Forest Youth Sports Association (collectively the "Associations") for the purposes described in Section 2. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
