6 AN ORDINANCE AMENDING SECTION 78.103
7 (MEMBERSHIP; TERMS), CHAPTER 78 (SAFETY AND
8 CRIME REDUCTION COMMISSION), *ORDINANCE CODE*, TO
9 CHANGE RESIDENCY REQUIRMENTS FROM CITY OF
10 JACKSONVILLE RESIDENT TO DUVAL COUNTY RESIDENT;
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Amending Section 78.103 (Membership; terms),**
15 **Chapter 78 (Safety and Crime Reduction Commission), Ordinance Code.**
16 Section 78.103 (Membership; terms), Chapter 78 (Safety and Crime
17 Reduction Commission), *Ordinance Code*, is hereby amended to read as
18 follows:

19 **Chapter 78. Safety and Crime Reduction Commission**

20 * * *

21 **Sec. 78.103. - Membership; terms.**

22 (a) The Commission shall be composed of no more than 20
23 members who shall be appointed by the City Council in
24 accordance with the following requirements. Members
25 shall be residents of ~~the City of Jacksonville~~ Duval
26 County or have substantial business interests within ~~the~~
27 CityDuval County (either employed by a business located
28 in ~~the City~~Duval County or volunteer, affiliate or serve
29 on the board for an organization whose principal place
30 of business is Jacksonville). Members shall serve

1 staggered two-year terms, commencing July 1, but shall
2 serve until their successors are appointed and
3 confirmed. Of the initial appointments, ten members
4 shall serve for one-year terms, and ten members shall
5 serve for two-year terms; but appointments to fill
6 vacancies for partial terms (less than 50 percent of a
7 full term) and initial appointments under the preceding
8 sentence for less than two years shall not be deemed to
9 be full terms. No member shall serve more than two full
10 consecutive terms. Members appointed pursuant to this
11 paragraph (a) shall serve at the pleasure of the Council
12 and may be removed at any time by the Council.

13 **Section 2. Effective Date.** This ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
