4 **ORDINANCE 2021-661-E**

5 AN ORDINANCE CLOSING AND ABANDONING AND/OR  
6 DISCLAIMING AN UNOPENED AND UNIMPROVED PORTION  
7 OF THE LEAHY ROAD RIGHT-OF-WAY ESTABLISHED IN  
8 THE ROBINWOOD ACRES UNIT NO. 3 PLAT, AS RECORDED  
9 IN PLAT BOOK 21, PAGE 43 OF THE CURRENT PUBLIC  
10 RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL  
11 DISTRICT 4, AT THE REQUEST OF ALEX CHAMBERS,  
12 SUBJECT TO RESERVATION UNTO THE CITY OF  
13 JACKSONVILLE OF AN ALL UTILITIES EASEMENT OVER  
14 THE CLOSED PORTION OF THE RIGHT-OF-WAY;  
15 PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS;  
16 PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Closure and Abandonment.** An unopened and  
20 unimproved portion of the Leahy Road right-of-way established in the  
21 Robinwood Acres Unit No. 3 Plat, as recorded in Plat Book 21, Page  
22 43 of the current public records of Duval County, Florida, located  
23 in Council District 4, a description of which is attached hereto as  
24 **Exhibit 1** and incorporated herein by this reference, is hereby closed  
25 and abandoned and/or disclaimed as a right-of-way at the request of  
26 Alex Chambers (the "Applicant"); provided however, there is reserved  
27 unto the City of Jacksonville an all utilities easement on, over,  
28 across, and under the closed right-of-way for ingress and egress and  
29 for all utilities. The Applicant paid the right-of-way closure  
30 application fee of \$2,091.00 and this amount has been deposited into  
31 the General Fund. This closure request was reviewed and approved by

1 the various city, state, and utility agencies that might have an  
2 interest in the right-of-way and there were no objections to the  
3 Applicant's request.

4       **Section 2. Purpose.** The Applicant is requesting the  
5 closure in order to clear out overgrowth within the closed right-of-  
6 way and to increase the aesthetic appeal of the closed right-of-way  
7 and Applicant's adjacent property (R.E. No. 163940-0000), subject to  
8 the conditions set forth herein.

9       **Section 3. Hold Harmless Covenant.** The closure and  
10 abandonment by the City of its interests in the right-of-way is  
11 subject to Applicant's execution and delivery to the City of a Hold  
12 Harmless Covenant, in substantially the same form attached hereto as  
13 **Exhibit 2** and incorporated herein by this reference. Accordingly,  
14 the closure and abandonment of the right-of-way shall not be recorded  
15 in the public records until execution and delivery to the City by the  
16 Applicant of the required Hold Harmless Covenant.

17       **Section 4. Effective Date.** This Ordinance shall become  
18 effective upon signature by the Mayor or upon becoming effective  
19 without the Mayor's signature.
