Explanation of Appropriation: (C)

> The funding above comprises \$260,000.00 in grant funds (the "Grant") from AmeriCorps Seniors (formerly known as the Corporation for National and Community Service) ("AmeriCorps") and an additional appropriation \$64,509.00 from the City from General Fund - General Service District Fund Balance, for the Duval County Senior Companion Program (the "Program"). The Grant period commences July 1, 2021 and ends June 30, 2024.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for the Program which focuses on providing aid and friendship to older adults who have difficulty with daily living tasks by connecting eligible seniors with Program volunteers. The Program serves seniors aged 60 years and older who have one or more physical, emotional, or mental health limitations and who need assistance to achieve and maintain a higher level of independent living. Program volunteers will visit the seniors 3 to 4 days a week, for a minimum of 4 hours, to provide companionship and assistance and a broader opportunity for social networking. Grant and matching funds will be used for Program staff salary and benefits, volunteer stipends, meals and mileage, volunteer recognition events, supplies, training and travel. The Notice of Grant Award is attached hereto as **Exhibit 2** and incorporated herein by this reference.
