RESOLUTION 2020-326-W

A RESOLUTION SUPPORTING THE PASSAGE OF POLICY DESIGNATING CITY HALL AS A "HIT FREE ZONE," TRAINING OF EMPLOYEES FOR ΑN APPROPRIATE RESPONSE, AND POSTING OF SIGNAGE AT CITY HALL IDENTIFYING THE PROPERTY AS A "HIT FREE ZONE" AREA; URGING THE CREATION OF A PILOT PROGRAM; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville is invested in supporting safe, healthy, and nurturing relationships and environments across the lifespan for all citizens in our community; and

WHEREAS, violence against children puts them at risk of developing increased aggression, antisocial behavior, and mental health problems as well as physical injury; and

WHEREAS, ending violence against children can reduce the risk that any given child will suffer child abuse, or engage in criminal conduct as an adult or juvenile; and

WHEREAS, research shows that when bad things happen to people children, there is a strong connection to their life-long physical and emotional health; and

WHEREAS, the Council believes that as a community committed to the well-being of children, the City can help to prevent and lessen life-long consequences of violence by promoting the well-being of children and adults in our homes and communities; and

WHEREAS, notwithstanding the parental right to discipline children, the Council believes that no physical violence should be tolerated within City Hall, which shall be designated a "Hit Free

Zone," which is an area in which no adult shall hit another adult, no adult shall hit a child, no child shall hit an adult, and no child shall hit another child; and

WHEREAS, as a designated "Hit Free Zone," City Hall will maintain a safe environment that does not allow violence of any kind; and

WHEREAS, the Council has determined that it is appropriate to train City employees so that all employees are prepared to have an appropriate response within areas designated as "Hit Free Zones", such as City Hall; and

WHEREAS, the purpose of the "Hit Free Zone" area is to create and reinforce an environment of safety and comfort for all people who come into City Hall; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. Council Support. The City Council strongly supports the designation of City Hall - St. James Building, located at 117 West Duval Street, as a "Hit Free Zone" area. The City Council also urges the Administration to develop a policy regarding the designation of City Hall as a "Hit Free Zone," including installation of signage at City Hall, and training for City employees for an appropriate response. The Administration shall be responsible for extending the designation to other city-owned properties and facilities as it sees fit. The Administration is also urged to work with the Constitutional Officers and allow them to develop policies for each of their own offices and facilities.

Section 2. Pilot Program. The Council urges the Administration to roll out a pilot program within six (6) months from the effective date of this Resolution. The pilot period should run for a period of one (1) year from the date that it is implemented by the Administration. The Administration is requested to provide a report which summarizes the findings and data

collected from the pilot program. This report is requested to be submitted to the Council at least 30 days prior to the conclusion of the pilot period so that the Council can assess the outcome of the pilot program.

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
