ORDINANCE 2021-815

AN ORDINANCE CLOSING AND ABANDONING AND/OR DISCLAIMING A 24 FOOT DRAINAGE AND UTILITIES RIGHT-OF-WAY ESTABLISHED IN THE WISPERING PINES PLAT, AS RECORDED IN PLAT BOOK 26, PAGE 15 OF THE CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL DISTRICT 10, AT THE REQUEST OF ROBERT'S DIESEL SERVICE, INC.; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Closure and Abandonment. The 24-foot drainage and utilities right-of-way established in the Wispering Pines Plat, as recorded in Plat Book 26, Page 15 of the current public records of Duval County, Florida, located in Council District 10, a description of which is attached hereto as Exhibit 1 and incorporated herein by this reference, is hereby closed and abandoned and/or disclaimed as a drainage and utilities right-of-way at the request of Robert's Diesel Service, Inc. (the "Applicant"). The Applicant paid the right-of-way closure application fee of \$2,091.00, which has been deposited into the General Fund. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

Section 2. Purpose. The Applicant owns the parcels situated on either side of the right-of-way closure area (R.E. Nos. 049022-0005 and 048970-0000) and is requesting the closure in order

to connect Applicant's parcels and to use the closed right-of-way area for storage and maintenance of school buses, subject to the conditions set forth herein. The subject right-of-way was never utilized for drainage or utilities and there is no infrastructure in the closure area.

Section 3. Hold Harmless Covenant. The closure and abandonment by the City of its interests in the subject drainage and utilities right-of-way is contingent upon Applicant's execution and delivery to the City of a Hold Harmless Covenant, in substantially the same form attached hereto as Exhibit 2 and incorporated herein by this reference. Accordingly, the closure and abandonment of the drainage and utilities right-of-way shall not be recorded in the official public records until execution and delivery to the City by the Applicant of the required Hold Harmless Covenant.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
