#### **AUDITOR COMMENTS**

- As filed, this legislation authorizes an extension of the completion date from 6/30/23 to 9/30/23. Since that date has passed, Council action will be required to authorize a new extension date.
- The DIA approved Resolution 2023-11-03 on 11/15/23 recommending that City Council amend the performance schedule to:
- 1) establish a Recommencement of Construction date which shall be 90 days following the effective date of the legislation, requiring evidence that a new general contractor has been engaged to complete the project and has begun on-site work on the project and
- 2) extend the Completion of Construction date from 6/30/23 to one year following the Recommencement of Construction date.
- As of 11/16/23, the Developer and Developer's related entities have liens totaling \$1,842,720.23 on their various parcels for the Ambassador Hotel, Independent Life, and 404 Julia Street/Central National Bank projects.
- The Developer has not met the performance schedules in the original Council approved redevelopment agreements for the Independent Life and 404 Julia Street/Central National Bank projects.

Phillip Peterson of the Council Auditor's Office explained that the amendment adopts the DIA proposal to extend the original completion date of the project, to establish a 90 day deadline for the developer to recommence the project, and to extend the completion of construction date to one year following the date of recommencement.

CM Peluso explained that the developer of this project had come before the committee last month to discuss the project. CM Peluso stated that the money involved is a completion grant, so if the developer is unable to meet the terms of the new agreement, the City will not be impacted financially. He stated that a year timeline would be more achievable than the possible April deadline discussed at last month's meeting and requested to be added as a co-sponsor.

The amendment to the bill was unanimously approved.

Lori Boyer, CEO of DIA, thanked the committee for deferring to the DIA's decision-making last committee meeting. She explained that there is still one lien on the property but that the developer has worked hard to convert the other liens to bonds. She reinforced that the developer must be current on all liens in order to recommence construction with a deadline of 90 days.

CM Clark-Murray asked Ms. Boyer for an estimation of the percentage of the project that has already been completed. Ms. Boyer said that the developer estimates that the project is 50% complete, but DIA estimates that this percentage is likely lower than the developer's estimation. CM Clark-Murray also asked about other projects with which this developer is involved; Ms. Boyer described the developer's other three major projects, including their development of the Independent Life Building, which has also had less-serious development issues. CM Clark-Murray observed that the City should not give additional contracts to developers with unfinished projects, and Ms. Boyer noted that these contracts are distributed based off a nuanced process which involves an assessment of the developer's capacity to complete the project.

CM Gay asked whether the developer was changing its general contractor; Ms. Boyer responded that they were. CM Gay observed that the 90-day recommencement deadline would be difficult for the developer to meet if it still had issues with its subcontractors and that this developer's difficulties with its subcontractors reflects a lack of due diligence on behalf of the developer. Ms. Boyer affirmed that the 90-day-deadline should be challenging, but also achievable, to the developer.

CM Peluso thanked CMs Clark-Murray and Gay for their perspectives, adding that CM Gay has a wealth of valuable experience in this field. He said that these issues often arise in public-private partnerships, noting a conversation that he had with Ms. Boyer in which they discussed the pros of the government's purchase of land directly, which gives government more freedom dictating the outcome of the property's development. He reiterated that the fact that this bill provides a completion grant, which is only paid upon successful completion of the project, thus reducing stress regarding this bill.

CM Boylan thanked the DIA for their work, noting that the City Council often relies on their work in development agreements.

# Clawback Language –

- In the event reporting requirements are not met in the time period specified in the agreement, the City will be entitled to withhold disbursement of the loan
- If FCNMHP fails to invest at least \$1,500,000 upon substantial completion of the project, the agreement will terminate
- If FCNMHP sells, leases, or otherwise transfers the project or project parcel during the term of the loan, the loan shall be due and payable at the closing of the sale
- If FCNMHP does not retain the retained jobs, and/or does not create and maintain a minimum of 6 permanent jobs at an average wage of no less than \$42,000 as of the new job creation deadline, and maintain the retained jobs and permanent jobs from the new job creation deadline for the remaining duration of the loan term, FCNMHP shall pay the City the entire remaining principal balance of the loan (less any amounts forgiven), which will be amortized over a ten-year period with 3% interest accruing annually, with payments due monthly

OED has not prepared an ROI calculation for this project.

Waives the NWJEDF Guidelines to authorize City funding in excess of 25% of the total project costs.

Phillip Peterson explained the amendment, clarifying the funding source of the appropriation, stating the deadline to execute the agreement, adding a waiver of the Public Investment Policy, and placing a revised Economic Development agreement on file to correct scrivener's errors and to add a clawback provision.

Mr. Peterson clarified that the Northwest Jacksonville Economic Development Fund guidelines typically limit government funding to 25% of a general project's cost, and the funds being provided in this project amounted to closer to 30% of the project's cost, so a waiver of this provision was necessary to allow this appropriation.

The amendment was unanimously approved by the committee.

Joe Whitaker of the Office of Economic Development introduced Jennifer Barker, CEO of First Coast No More Homeless Pets (FCNMHP), to answer questions on the bill.

CM Boylan explained his background in the nonprofit sector. He asked Ms. Barker whether FCNMHP had taken any action to raise funds for this project. Ms. Barker responded that FCNMHP could make up the difference between the City loan of \$500,000 and the total project cost of \$1,615,000 based on pledges that the organization had already received.

CM Clark-Murray asked for background information on FCNMHP, including for information on their number of employees and of minority employees. Ms. Barker explained that FCNHMP was founded in 2002 to provide affordable veterinary services, with a specific focus on spay and neuter services. She said that FCNHMP has about 40 full-time employees at its Norwood facility and about 50 at its Cassat facility, with additional volunteer support. She said that she is willing to provide statistics on minority employment but did not have them at this time. CM Clark-Murray clarified with Ms. Barker that this bill funds the renovation and expansion of the Norwood facility.

CM Peluso said that many of his constituents are concerned with overcrowding at shelters in his district and asked whether this appropriation could alleviate pressure on these facilities. Ms. Barker explained that FCNMHP is not a shelter but could alleviate pressure off of shelters by providing medical services and collaborative grant writing that could reduce the amount of animals that end up in shelters.

CM Boylan asked whether FCNHMP is currently at capacity to perform, and Ms. Barker responded that they were. The expansion of the Norwood facility would allow FCNMHP to hire an additional surgeon and other additional staff.

Phillip Peterson explained the amendment correcting language and the correct amount of grocery store locations within program boundaries.

The committee unanimously approved the amendment.

CM Boylan invited Ed Randolph of the Office of Economic Development to speak on the bill. CM Boylan asked Mr. Randolph about the closure of the two grocery stories within the program boundaries, and Mr. Randolph explained that these closures exemplify the problem of the difficulties that grocery stores have in turning a profit in areas without sufficient density.

Mr. Randolph explained that this appropriation funds to the JTA to fund the Door-to-Store Program, one of three major initiatives under OED's Food Desert Program. This program is driven by a 2019 study done by the City that concluded that access to fresh produce is significantly lacking in specific areas of the City. JTA maintains day-to-day operations of the program, offering transportation to grocery stores within the program boundaries. The program currently averages 167 uses a month and requires annual reauthorization.

CM Peluso observed that Baldwin provides funding for a public grocer and noted that Jacksonville had provided similar programs in the past and could again in the future.

CM Clark-Murray expressed her gratitude for the service that the program provides. She asked for Mr. Randolph to clarify the boundaries of the program. He explained that the program boundaries flank the I-95 corridor. CM Clark-Murray asked about program advertisement, and Mr. Randolph explained that JTA handles marketing for the program, using both online and direct community engagement strategies.

All present members of the committee requested to be added as co-sponsors.

• The FY 23/24 Council approved budget includes \$200,000 for operation of the Sexual Assault Resource Center (SARC) by the Women's Center

CP Salem explained that the Women's Center of Jacksonville approached him about a cut to their federal funding that would make continued operations difficult. Teresa Miles, Executive Director of the Women's Center of Jacksonville (WCJ), explained that the \$200,000 federal cut that the WCJ received would make it difficult for the WCJ to hire forensic nurses and that this appropriation would rectify this issue.

CM Peluso confirmed with Ms. Miles that the WCJ collects and retains sexual assault forensic evidence at its facility until state investigators come to collect it, thus providing a service to state investigators and JSO in addition to providing a safe place for victims of sexual assault. He requested to be added as a co-sponsor.

CM Boylan requested that Ms. Miles clarify the specifics of the term sheet between the WCJ and the City, and Ms. Miles stated that this money would be used to hire staff in its forensic center.

CP Pittman noted that WCJ services are also available to men who are victims of sexual assault, and Ms. Miles added that 8% of such services are administered to men.

CP Salem thanked the administration for its collaborative approach to this legislation, and Ms. Miller thanked and recognized Chantel Sherer, the Development Director of WCJ.

Phillip Peterson explained the amendment, which attached a revised Budget Transfer form and CIP Project Sheet reflecting the appropriation amount. CM Boylan also requested that Mr. Peterson provide a high-level explanation for the \$1.8 million amount. Mr. Peterson explained that the City received a market value from an independent appraiser, who provided the \$1.8 million amount, on August 11, 2023.

The amendment was unanimously approved by the Committee.

CM Pittman explained how she inherited this situation involving this property, which involved a property owner constructing a building close to a school with the intention of using the building as a liquor store, and she invited Renee Hunter, Chief of Real Estate, and Daryl Joseph, Director of Parks, Recreation and Community Services, to speak on the bill.

Ms. Hunter explained that the property appraiser used a cost-analysis approach to reach the \$1.8 million amount. The appraisal found several comparable properties, and the total \$1.8 million included an appraisal of \$1.14 million for the building and the remaining amount for the property and attorney's fees.

CM Boylan asked whether the administration approached the property owner to ensure their acceptance of the independent appraisal, and Ms. Hunter stated that she was not privy to the specifics of the negotiations. CM Peluso asked who was responsible for the negotiation, and Bill Delaney, Council Liaison to the Mayoral Administration, responded that the administration was responsible for this negotiation. Mr. Delaney stated that this process required compromise between the property owner and the community. CM Pelsuo observed that this area is likely considered a food desert and that this property could be used to mitigate the problem of lack of fresh food in the area.

CP Salem asked whether there would be restrictions on the property after its purchase by the City, and Mr. Joseph stated that property would become the responsibility of the Parks Department and could not be re-sold without further legislation.

CM Clark-Murray noted that the property was formerly a gas station and asked whether the environmental affect of the gas tanks had been abated. Ms. Hunter responded that the state has agreed to do all environmental clean-up using state funds.

CM Gay observed that it is an unfortunate situation that the City is using public funds to bail out a bad actor, emphasizing the importance of the Council's role as stewards of taxpayer money.

CM Carlucci noted that this dispute arose as a result of a lack of communication between the Planning Commission and the community during the COVID-19 pandemic. He said that parents have valid objections to a liquor store's construction near any kind of school. He stated that he supports the bill; the use of this property as a community center will benefit the community, even if he did not approve of the process to get to the end result. CM Lahnen confirmed with Mr. Joseph that the property would be used as some kind of community center as per this legislation.

CM Clark-Murray asked Mr. Delaney whether any other options other than paying the \$1.8 million to the property owner were considered in the negotiation process. Mr. Delaney said that the administration

looked at many possible options, but the fact that the construction of the liquor store had already been approved when the community raised its objections limited the administration's options. CM Clark-Murray asked about potential uses of the property; Mr. Joseph said that the property is a blank slate at this point. CM Clark-Murray stated that she was on the CPAC, which voiced its disapproval of the use of the property as a liquor store, and that the Planning Commission and property owner disregarded the community's objections. She stated that it was dangerous precedent to reward a property owner for ignoring community objections.

CM Carlucci said that the Planning Commission is perhaps too quick to approve anything that comes before them, and he said that listening to CPAC input is an important role of sitting on the Planning Commission. CM Pittman stated that community involvement is integral to the planning process, especially if the Council's goal is to maximize transparency, even if it is impossible to make everyone happy. She noted that the Gateway Shopping Centers is working to bring grocery stores to the region to address the food desert issue. She reiterated her support of the bill, as she believes that creating a community center of some kind with the property will be an enhancement to the community.

CM Boylan asked about the difference between the disparity between the property value and the building value, and Mr. Joseph stated that, because of current building costs, it would be difficult to construct the building intended to be used as a liquor store for less than \$1.5 million. CM Boylan noted that he believes that the end result is community investment, which he supports, even if the process to get to this community investment was messy.

Jerry Holland, Supervisor of Elections, explained that because of a lawsuit regarding unequal access to voting precincts across the City, the SOE has reduced the total number of voting precincts in the City from 186 to 161, with these precincts being more evenly spread throughout the City. The goal of the SOE is to now inform constituents of these precinct changes. New voter cards reflecting precinct changes should be sent out in early December, and new precinct signs should be completed by January. Mr. Holland stated that the SOE will conduct TV interviews in order to further communicate precinct changes to people. If constituents do attempt to vote at defunct locations, the SOE will have a poll worker stationed there in order to divert constituents to their correct precinct location.

CM Boylan requested that the SOE continue to keep the City Council updated on how and when they are communicating with constituents.

CM Peluso asked about whether the precinct boundaries were set in place until the 2030 Census; Mr. Holland clarified that precinct boundaries can change based off of need but that district boundaries are set in place until the 2030 Census. Mr. Holland stated that he is willing to add more precinct locations, but there needs to be equal access to voting across districts. He added that any change to the precinct boundaries needs City Council approval. CM Peluso said that it would be possible to hire more poll workers if that is what is necessary to increasing the number of precinct locations across the City. CM Boylan observed that it is common for precinct locations to change based off individual schools or churches no longer being able to accommodate being a voting precinct.
