President Wilson welcomed the committee and thanked them for taking on the challenge of Finance. He asked them to please scrutinize the budget carefully and please entertain discussion by and make motions for visiting council members. The agenda meeting is an opportunity to get prepared for the committee meeting by asking questions and requesting information in advance. He requested that council members be patient with the new computer system and let staff get acclimated to how everything works.

Chairman Bowman announced that the school district sales tax bill (2019-380) will be moved to the end of the agenda. Public comment will generally be taken at the end of Finance Committee meetings unless a meeting runs very long.

Council Auditor's Report #766B - Follow-up on JPA Payroll Second Follow-Up: Council Auditor Kyle Billy reported that the original audit identified 4 issues, including payroll payments for overtime and out-of-classification pay not being correctly calculated; the payroll system required some manual calculations that were sometimes done incorrectly; and excessive computer access rights. In response to a question from Council Member Salem about how was this audit ranked overall, Mr. Billy said that it was fairly average and, while it took 2 follow-up reviews, all issues have been remedied and the audit is considererd closed.

Mr. Billy discussed Resolution 2019-500 - the TRIM notice tentative millage rate adoption - that will be introduced and needs to be adopted as an emergency on first reading at next week's council meeting. He said the tentative millage rate should represent the largest amount the council thinks it might need to levy to raise the desired revenue; the tentative rate can always be reduced in the future without problem, but increasing the rate after initial publication requires new notification of all taxpayers entailing considerable time and expense. His advice was to set a higher rate initially than might be needed and lower it later in the budget process.

Council Member Cumber moved deferral and listed a number of items that the City Council needs to fully understand before it approves the referendum. including the impact the sales tax will have on the City's credit rating, a detailed list of what schools will be repaired/replaced and in what order, enrollment trend assumptions, provisions for charter schools equity, the timing of the state-mandated OPAGA audit, etc. She felt that it was not entirely clear where the School Board stands on the issue of sharing sales tax revenues with charter schools and said that with the Council immersed in the budget hearing process through August and into early September, it will be nearly impossible to do full justice to this issue in time to schedule a November 2019 referendum. Council Member Salem agreed with the proposal to defer and cited a need for additional information regarding charter schools, construction costs, and a detailed timeline for renovations and new construction; he proposed the creation of a monitoring committee similar to the one that oversaw the implementation of the Better Jacksonville Plan projects. Council Member Hazouri expressed support for the referendum, but only if it is done at the proper time and under the right conditions to ensure its success. He believes there are still substantial unanswered questions and supported deferral until the School Board, Mayor and City Council can all "get on the same page" and move the issue forward together. Council President Wilson suggested that holding the referendum in 2020 would be preferable and proposed holding a joint School Board/City Council meeting in early October to thoroughly discuss all the questions that have been raised. Council Member Pittman agreed with the deferral and said she needs to know more details about the plans to close and replace schools, many of which are in her district. Council Member DeFoor said that what has been presented by the school district thus far is a cost estimate list, not a full-blown, prioritized construction plan.

Council Member Freeman said that the students are the most important thing and they need to see that the community cares for and supports them. He said council members are bound to do their due diligence before voting for any legislation, and he needs to know what areas of town will get top priority for work to address decades of neglect. Council Member Bowman thought that a

joint working group with the School Board is a good idea. He said that special election turnout is always extremely small and that doesn't represent the community's will for a multi-billion dollar issue. The OPAGA performance audit is crucial to the process and must be posted at least 60 days before the election (Sept. 5 for a November 5, 2019 referendum). He understood that Lee County's OPAGA audit took 4 months to complete and post. He noted that many school districts across the US are going to public/private ventures to build and lease schools. IDEA Schools has proposed to open 15 schools in Jacksonville. He believes that the School Board administration building needs to be moved off the riverfront, possibly into leased space, and said that a successful referendum will require a great, well funded marketing effort to pass. Council Member Carlucci advocated for holding the referendum this fall to begin immediately rectifying decades-old problems. In response to a question from Mr. Carlucci, Council Auditor Kyle Billy said that his office has looked at the reasonableness of the School Board's sales tax revenue estimates and finds them reasonable based on current trends and assumptions. Mr. Carlucci said the School Board is present and ready to answer questions today but doesn't get the chance because Council won't ask them directly. He said that School Superintendent Greene has led 4 successful referendum campaigns in the past. He has attended several of the School Board's town hall meetings and was impressed by the information presented there. He said he has posed questions to the school district and gets prompt answers. Council Member Salem said that several important issues how charters will be treated, how the plan will be overseen by a monitoring committee - are policy issues need to be dealt with by the board, not questions about facts.

Public Comment

Rev. Aaron Flagg said that a hidden agenda of politics and lies is at work to thwart the school sales tax referendum; the school district is facing an emergency now and the referendum needs to be done now.

lla Rae Merton said that as a parent and former teacher she has seen the terrible conditions in the schools over many decades; our children deserve better and the schools need work now.

Nahshon Nicks said that Jacksonville's children will never get a competitive education without competitive school facilities; schools are overcrowded and underfunded.

State Senator Audrey Gibson said that if the Legislature wants answers to questions it holds hearings and lets people present information and answer questions. Supperintendent Greene is experienced with getting school tax referenda aprpoved. The School Board has produced a facilities plan and she doesn't understand what the City Council's problem is with approving a referendum. Charter schools are being respected in this process. It is City Council's job is to put the question on the ballot and let the public decide the issue. OPAGA is ready to contract for an audit immediately. School attendance patterns have been taken into account by the plan.

Terry Bork said that City Council is violating the Florida Constitution and state statutes by inserting itself into school business – that's the School Board's job. The Florida Attorney General has ruled that "shall" means "shall" with regard to putting the sales tax on the ballot. He understands that OPAGA has been told by someone in the City government that they shouldn't do anything regarding a study before the Mayor signs the referendum bill. If the Council really want answers, it should compile a definitive list of questions and present them to the School Board for response.

Judy Shecklin believes that the School Board's plan is real and definitive and has priorities, She is disappointed that the committee members came in with minds already made up and aren't willing to listen to input.

School Board Chair Lori Hershey said that every time a question is answered, more are piled on. OPAGA delayed the release of its info packet to the School Board because someone at City Hall appears to have interfered with the process and told them to wait. Idea Schools can locate within 5 miles of a closed school but don't have to operate the same kind of school that closed (i.e. a middle school could be opened near a closed elementary school). Duval's recent school grades reduced the number of Idea schools that can locate in Jacksonville from the 15 cited in earlier discussion. She asked when the Council will give the people the opportunity to vote?

Rev. Rachel Gunter Shapard said that public schools are the basis of common good and the good of the community and its economy. Everyone loses when public education suffers and the city's future is at risk. Hold the referendum now.

School Board Member Ashley Smith Juarez said the school district board and staff have given tremendous time and attention to all of the questions the council has been posing and have those answers. Part of the reason for consolidation in the 1960s was to improve equity across the community for everyone. The School Board has thought about equity and fairness in what the schools need. The Council needs to play its proper role and put the referendum on the ballot.

Dave Hollingshead wants the referendum held in 2019. Jacksonville's school facilities are not equal across this community. Let the people vote and if they choose not to turn out for the referendum, they've spoken.

School Board Member Darryl Willie said the board has done its due diligence and now it's up to Council to act. They are here and ready to answer questions if only Council would act. They've addressed fairness for charters and have changed the enrollment assumption timeline. Polling shows that this referendum will pass overwhelmingly. The School Board and City Council need to be partners to get the job done.

John Nooney said the referendum is not ready for a November 2019 vote. It seems like the plan allocates excessive funds to the urban core. He said the School Board building site should be a kayak launch point.
