He stated that the biggest piece of contention within the bill will most likely be the zoning aspect.

4. St. Johns River Status Report on Water Quality and Manatees - Dr. White & Dr. Pinto

Dr. White spoke about Hurricane Dorian and the possibility of more hurricanes on the horizon. The salinity levels remain low. Water temperature remains high which can help fuel hurricanes if they end up moving in this direction.

Dr. Pinto had no new news to report in terms of manatees. He just reminded the commission that there have been 5 mortalities overall for the year. He also shared that on Friday there will be the Environmental Summit at UNF.

Reed Island and Harbor Waterways Special District

Commissioner Birtalan made a PowerPoint presentation which gave an overview of the Reed Island project. He was joined by Stanley Pipes, District Manager of the Harbour Waterway Special District. Mr. Birtalan started by giving a history of the Reed Island site. Mr. Birtalan detailed what has been done in the Special District. 4,000 feet of nature trails have been cut by the Special District and there has been a maintenance committment for the trails and easements. An invasive species has been removed from the island. Mr. Birtalan detailed the contracts that are in place in the Special District.

Mr. Adkison asked about the twenty year plan for dredging. Mr. Pipes said it is possible to dredge, but the issue would be where the dredge spoil could be put after the dredging. Mr. Adkison asked about the nature trail and the city park aspect. Brian Burket, Parks and Recreation Department, said that this was part of the City's wishlist to be added to the project on Reed Island with the amenities such as the trail and overall access. The trail will connect to the dock and a picnic area. Mr. Swann asked how will this plan work with Reed Island Management. Mr. Pipes clarified that Reed Island Management is a dredging company that has purchased disposal space within the area. Chair Ferraro highlighted the amazing work from so many people that have made the project possible.

Container Under the Dames Point Bridge

Mr. Suber detailed the work he has done to get clarity on what can be done with the container trailer. The water was removed from the trailer, but the trailer remains in the river. DEP has given a notice of violation to six different entities which are connected to the trailer. DEP is working to find a resolution to this issue. Mr. Adkison asked if there was something that can be done on the State level about these trailer containers because they just keep being left in the water. State Rep. Byrd said that waterways are a top priority and is looking to build cooperation between the State and local government. Chair Ferraro emphasized that there is money available to remove the derelict vessels with a timetable, and once these structures are recognized by the state as "derelict vessels" then the money can be used to remove them from the waters. Mr. Adkison emphasized the need for communication due to the process being filled with red tape which can become very time consuming.

Derelict Vessels in the Ortega River

Susan Grandin presented information regarding the two derelict vessels in the Ortega River. Pictures of the vessels were handed out to the Commission. Ms. Grandin described that the process begins with FWC and having the vessel identified as derelict. Ms. Grandin explained that there is an issue where a floating structure and a derelict vessel have the same definition. This allows for unregulated floating objects. The State Statute allows local governments to regulate where floating objects can be in the river. Chair Ferraro stated that the issue is two-fold; one is the funding aspect and the second is getting it recognized by the State as a derelict vessel. FWC has started a process with one of the derelict vessels. Mr. Suber gave an update of the 8 derelict vessels that are currently being looked into by the FWC.
