Chair Salem went through the agenda and noted the actions that would be taken for each bill. He explained that they would take up bill 2020-0568 first following the Recycling Presentation by the Public Works Department.

John Pappas, Public Works Department, gave a presentation regarding recycling in the City of Jacksonville. Mr. Pappas provided a general overview of the City's multifaceted recycling program. The City currently recycles 59% of the solid waste (measured by weight) that is generated all across Jacksonville. A chart showing the breakdown of the percentages was displayed with construction and demolition debris coming in on top at 21% and everyday curbside residential recycling at the bottom at 2%. Mr. Pappas went over the details of the residential curbside pickup recycling program. He noted two Florida State Statutes (403.7032, 403.706) that are the basis for the establishment of recycling programs within the state of Florida. Currently, Duval ranks 13th out of 67 counties in regard to the quality of our recycling program. Section 380, Part 5 of the Jacksonville Municipal Code establishing local recycling requirements for residents.

Lists were provided of materials that currently are, and are not, accepted in curbside recycling pickup. Items accepted include multiple types of paper, cartons, plastics, glass, and metals. It is noted that recyclables should not be placed in plastic bags and that all items should be clean, empty, and dry. Unacceptable items include #4 and #6 plastics, any plastics not marked with a recycling symbol, colored glass other than green and brown, and many other everyday items. Mr. Pappas said that Jacksonville uses a "single stream" method for collecting curbside recycling materials. This method has the resident place all of the recyclable materials into a single recycling bin. The recycling trucks come on a biweekly schedule.

Mr. Pappas provided a breakdown of the different waste haulers that operate in Jacksonville and their respective service areas. The major waste haulers include Southland Waste Systems (Northeast Jacksonville), Advanced Disposal (West Jacksonville), Waste Pro USA (Southeast Jacksonville), and the City's in-house haulers (Downtown Area). Additionally, there are other smaller waste hauler services operating in Atlantic Beach, Neptune Beach, Baldwin, and through the Navy. Statistics were provided noting the breakdown of residential premises that are serviced biweekly. Overall, the City provides recycling services to approximately 279,600 premises. Approximately, Southland Waste Systems serves 77,000 premises; Waste Pro USA serves 77,400 premises; Advanced Disposal Services serves 73,800 premises; and the in-house City haulers serve 51,400 premises.

Mr. Pappas said that all of the collected curbside recycled materials are taken to Republic Services Materials Recycling Facility (MRF) that is located at 7000 Imeson Road. The facility is operated by Republic Services and they have invested over \$2.7 million dollars into the facility. A brief overview of the facilities operations and services was presented.

Benefits of the City's Recycling Program were presented. Benefits to the environment include the conservation of natural resources, the energy savings by not having to

produce more materials, and the prevention of pollution that is generated from the collection of raw materials. Additionally, the program reduces the amount of waste that is sent to the landfill increasing the landfill's lifespan.

Costs of the Recycling Program were presented. The City pays MRF \$53.83 per ton (approx. 46,750 tons per year) for processing. This annual processing fees equates to approximately \$2.51 million dollars annually. The City does receive some revenue from MRF. When MRF sells the processed recycled commodities, the City receives have of the revenue. Currently, the revenue from this process is estimated at \$1.1 million dollars annually. The cost to expand the landfill is \$16 to \$20 per cubic yard of "air space". Recycling eliminates the need for 44,413 cubic yards of air space. This equates to saving approximately \$800 thousand dollars annually. The estimated cost of the FY 2020/2021 Recycling Program is at an expense of \$1.53 million dollars. Mr. Pappas explained that a few years ago the program had an annual revenue of nearly \$1.5 million dollars. This is a swing of nearly \$3 million dollars from the "black" to the "red".

Mr. Pappas went over some of the challenges within the Recycling Program. The biggest issues is the processing expense due to contaminated materials. Residents are not following the recycling guidelines and placing non-recyclable materials into the recycling bins. Currently, 19.5% of the material collected during curbside pickups is deemed "non-recyclable/contaminated (costing the City approx. \$132,000). This adds a significant processing cost to the MRF expenses. Additionally, there are problems with the sale of the processed recycled commodities. The markets for the materials have changed for various reasons, and for glass in particular, the City no longer receives any revenue for the sale of glass, but rather pays to have the material recycled. A composition of the recyclable materials from a typical load that is delivered to MRF was presented. Percentages for each type of material were shown with an emphasis on the "non-recyclables/contaminates" comprising 19.5% of the load. Following the presentation, Chair Salem opened the floor to questions.

Council Member Cumber asked about the financial impact of eliminating the Recycling Program and if there has been any research conducted as to what other cities have experienced since eliminating their recycling programs. Mr. Pappas said that the City has not yet done that type of analysis but that is something that the City should start to look at.

Council Member Morgan said that she is very excited to eventually go through all of the variables of the Recycling Program and to try and find ways to make the program more effective. Council Member Morgan opined on the overall importance of recycling noting that the environment cannot sustain without major updates to our waste handling methods and habits.

Council Member Becton opined on the importance of recycling and the overall relationship between the USA and China regarding recyclable materials as a commodity. Council Member Becton discussed the MRF and noted that recently there has been a lack of education around local recycling in the community and called for

further community awareness efforts. Council Member Becton asked if there are any recycled materials that are not considered contaminated but end up in the landfill because of a lack of resale value and/or lack of resale market. Mr. Pappas said that it is his belief that there are not any particular types of items that are ending up in the landfill due to backup or a lack of a market. Mr. Pappas said that because of the contract with the City, MRF is behooved to do their best to sell as much of the recycled materials as possible because they receive 50% of the revenue. Council Member Becton asked about the status of the hazardous waste events across the City, noting an event from his district in June and the COVID-19 pandemic. Mr. Pappas said that the main solid waste facility on Commonwealth Avenue is still open for hazardous waste drop offs from Tuesday through Saturday, 8:00 AM to 5:00 PM, but the different satellite locations have been closed due to the COVID-19 pandemic.

Council Member Ferraro asked about the age of the model that is used by the City for waste/recyclable hauling and if it needs to be updated, particularly in regard to transfer stations and other recently discussed methods. Mr. Pappas said that there will be a presentation on transfer stations given to the TEU Committee in October. Mr. Pappas discussed some of the recent changes to the waste/recycling model noting the change from having the residents separate the recyclable into separate bins to having everything put into a single bin. Mr. Pappas referenced Council Member Becton's point and stressed the need for more community education regarding proper recycling habits.

Chair Salem opined on the 19.5% contaminant rate noting that there is a strong desire in the community to recycle but there needs to be more education on how to recycle properly. The Chair encouraged having an annual analysis for determining what materials still make sense financially, environmentally, and logistically for the City to recycle.

Council Member Boylan asked about the issue with recycling glass. He noted a trip last year to the MRF where he was told that it would be more cost effective to put the glass into the landfill, but a year has passed, and the City is still recycling glass. Mr. Pappas said that it is true that it is costing the City money to recycle the glass materials, but that cost is still less than the cost of expanding the landfill to accommodate the addition of the glass materials.

Council Member Becton reemphasized the point that if recyclables are put in the recycling bin in any type of bag, that bag automatically goes to the landfill regardless of what is inside of the bag.

## **DEFER (Pursuant to Section 21.11 City Charter)**

COMMENTARY: Council Member Boylan provided the strategy and timeline for TEU Committee discussions as they relate to the bills comprising the Article 21 (JEA) Charter updates. There will be a discussion at each TEU meeting from now until the middle of November that will focus on a particular bill. The bills will be deferred, but there will be a discussion regarding the bill's specific topics as it relates to the overarching Charter updates. The topic for this week's discussion is JEA Board Member Appointments and Transparency. The overarching bill is 41 pages long and the reference point for the discussion topics. Highlights from the pertinent section of the bill were presented regarding Board Member Appointments with specific page and line references given. Council Member Boylan said that there will be limited focus on Board Member Appointments in this discussion because this section has been thoroughly reviewed and vetted in other arenas. Particular focus was given to the topic of Transparency. Council Member Boylan discussed specific highlights of the legislation as it relates to transparency, including JEA meeting procedures, the adoption of procedural rules, the delivery of meeting materials to the Council Auditor's Office, and the encouragement of JEA to adhere to best practices and recommendations regarding openness and transparency. Specific page and line numbers were provided for the aforementioned topic areas. JEA Board responsibilities and accountability were discussed. There were six focus points relating to this topic, including governing documents, real estate, new business lines, transfers, employment, and procurement. The specific Article Sections and definitions

were provided for each of the focus points.

Kurt Wilson, JEA, provided a brief update on the status and procedure for creating an updated JEA Board Policy Manual noting that the creation of the policy is being approved topic by topic at the JEA Board Meetings with the anticipation of revamping the Board Policy Manual to reflect any Article 21 of the Charter changes that are made. Mr. Wilson anticipates the inclusion of a transparency statement kin the final version of the Board Policy Manual. Council Member Boylan noted the inclusion of the phrase "board may not delegate approval authority" appears throughout the bill to act as an accountability measure.

Chair Salem asked about the JEA property on the Northside of Jacksonville that recently closed and about the ability for JEA to sell real estate in the newly updated Article 21 procedures. Council Member Boylan said that this issue will be discussed and better served at the October 19th joint TEU/Finance meeting.

Council Member Boylan noted the specific sections throughout the bill that requires JEA to provide the Council Auditor's Office with the required documentation, materials, and/or responses within the prescribed timeframe for each. These sections include 21.03(c) – Transparency in Meetings; 21.04 (p)(3) – New Business lines; 21.04(v) – New Utility System; and 21.07(m) Fiscal and Budgetary Functions. Additional sections were mentioned that deal with transparency through a requirement of providing annual reports to the various municipal agencies and the public. The bill also addresses transparency through online document posting. There are sections that will require JEA to post documentation from any meetings and procurement policies and procedures to the JEA website in a manner that is easily and readily available to the general public.

Lawsikia Hodges, Office of General Counsel, provided additional amendments related to transparency that could possibly be included within the bill, including the requirement to have real estate rules and procedures to be posted on the JEA website and easily accessible, and to require all JEA reports to be posted in the same manner.

Council Member Boylan discussed ways for JEA to maintain transparency with the general public trough public engagement efforts, including hosting town hall meetings, JEA workshops, and making all JEA information readily available to the public.

Following the discussion, Chair Salem noting the recent issues with JEA over the past few years encouraged JEA to have a single contact person that will be responsible for addressing and responding to public transparency issues. Kurt Wilson, JEA, said that he would suggest that he should be that person since he is already in daily contact with the Council and other municipal agencies and

reconfirmed JEA desire to adhere to all of the provisions in the revised Article 21 of the Charter. Council Member Boylan applauded JEA for being extremely accommodative during the process of revamping Article 21 of the Charter. Council Member Ferraro and Chair Salem applauded Mr. Wilson for his efforts and cooperation during this process.
