Council Member Dennis advocated for the bill to help the City know in advance who is going to be asking for legal fee reimbursement. He said General Counsel Jason Gabriel had told him that JEA-related legal fees could be as much as \$3 million. He knows the OGC has established a policy for reimbursement and wants to hear an explanation of that policy. Jon Phillips of the OGC said the policy codifies past practice with some new requirements. Invoices need to be submitted within 60 days of the completion of the service provided with details of what work was done and a copy of the agreement with the attorney. Attorneys must comply with City travel, lodging and meals policies. Mr. Phillips said he has spoken with Mr. Gabriel and does not believe that JEA-related legal costs will approach the amount Mr. Dennis cited earlier.

Council Member Cumber asked about any changes made to this bill since introduction. Mr. Dennis said he is agreeable to striking the advance notification requirement from the bill, but wants a fee cap imposed. In response to a comment from Ms. Cumber about the retroactivity clause being unusual, attorney Paige Johnston of the General Counsel's Office said that provision will come out if the amendment striking the notification process is approved. Council Member Salem said he would like to see the OGC's written policy and the proposed amendments before voting on the bill. Mr. Dennis agreed with deferring the bill so everyone can read everything and be prepared to vote next time. He said he is willing to strike p. 2 lines 24-31 and p. 3 lines 1-2 regarding the notification requirement and to strike p. 3, lines 8-14, also regarding advance notification. The bill was deferred.

AMENDMENT

Clarify the early retirement option has already been collectively bargained and place MOUs from unions on file

Brian Parks explained the amendment. Council Member Cumber expressed concern about the exclusion of JEA employees from the early retirement option. The JEA unions have not taken a position on the bill, so that's unsettling and says there must be some issue remaining unresolved. She doesn't agree with putting JEA employees in the position of having to file a grievance to have their issues addressed. She thinks JEA's argument about the potential huge loss of experienced personnel is problematic, especially the implied threat that system operations would be imperiled. JEA needs to have a good succession plan in place that takes all potential situations into account. She can't vote for the bill if JEA management has opted out for its employees. Kurt Wilson of JEA said the bill exempts Sheriff's Office and Fire and Rescue Department personnel already. JEA has a succession plan and it works well for the usual 5% per year turnover. They don't know how many people will want to take advantage of this option so are planning in the dark and it could be disastrous if everyone eligible (one third of their workforce) took the option at once. He said a grievance process is not necessarily adversarial – it's just a way to reach resolution of an issue.

Chairman Carlucci said he would like to hear from all the JEA unions about their positions before he is asked to vote. Council Member Priestly Jackson asked why this issue is not subject to collective bargaining. She got a memo from OGC yesterday saying this is not an issue for collective bargaining under the Ordinance Code, but she doesn't think the memo adequately addresses the issue. This definitely seems like an issue that should be bargained since it's a modification of rights under Ordinance Code Chapter 120 and can't be excluded just because JEA management wants it that way. She believes this is an unfair labor practice on its face. Ms. Cumber agreed this is a collective bargaining issue – it's changing a condition of employment. JEA management and unions need to negotiate and agree on this proposal. In response to a question from Council Member Salem about whether the City unions have agreed to this bill, Ms. Sidman said they have. With regard to the police and fire unions, Ms. Sidman noted that they not part of the General Employees' Pension Plan so are not covered by this bill or Chapter 120 of the Code.

Council Member Priestly Jackson questioned Sean Granatt of the General Counsel's Office about his memo cited earlier regarding exclusion of JEA employees as not being a modification of employee rights subject to collective bargaining. Mr. Granatt said JEA employees' pensions are not changing at all by their exclusion from this bill, so no collective bargaining is required. Ms. Priestly Jackson said the JEA employees are covered by Chapter 120 of the Code, so they ought to be allowed to bargain this issue. JEA management can't make the call to exclude them from this bill's effect on Chapter 120 and she believes everyone should be treated the same. In response to a question from Council Member Morgan about who has agreed to MOUs, Mr. Wilson said the JEA's unions have spoken with their Human Resources Department about it but have not taken official positions nor asked to negotiate any further. Brian Parks said the MOUs have been agreed to by the COJ unions and the Jacksonville Housing Authority's, but not JEA's unions. Ms. Morgan wondered if the City Council could ask the JEA unions to come and comment before taking action.

Council Member Dennis explained the circumstances that led him to introduce the bill to assist elderly employees afraid of COVID to retire early for their safety and peace of mind. He doesn't think JEA management can unilaterally exclude JEA unions from participating in the plan. He recommended deferral until the Council hears from the JEA unions. In response to a question from Mr. Dennis about what percentage of City employees took advantage of the last

early retirement option, CFO Joey Greive said that of the approximately 500 eligible City employees, about 25% took the offer. Council Member Salem asked if it would be appropriate to get written statements from the JEA unions about how they feel about the proposal. Kurt Wilson said JEA management can't compel the unions to take a position, but he would ask if they would voluntarily. Mr. Salem said he would like to hear from JEA's new CEO about the potential impact of the bill on its operations, what could be workable, etc. Chairman Carlucci recommended deferral of the bill. Council Member Cumber said that comparison of this situation to the retirement options contained in the potential JEA privatization is a false comparison; this needs to be collectively bargained. Apparently a big problem is JEA's succession planning and that needs to be addressed. She urged an end to the alarmist "the sky is falling" arguments. Council Member Priestly Jackson said the City Council is not trying to get into the collective bargaining process, but the unions have the right under Chapter 120 and can't be prevented from bargaining by JEA management's unilateral decision. Ms. Sidman asked for clarification from the committee about whether to file the Auditor's amendment approved earlier, and was instructed to file the amendment despite the deferral.

Public Hearing Pursuant to Chapt 166, F.S. & CR 3.601 – 1/12/21

Council Member Pittman explained the purpose of the bill and how it addresses constituent concerns about large and unruly gatherings. She believes some businesses are abusing their business licenses by allowing large parties to take place at their businesses. Chairman Carlucci said that there are problems around the city and sometimes new techniques need to be tried to deal with persistent problems. He supports the bill. Council Member Priestly Jackson said there are already state laws and local ordinances that can address this problem. She opposes criminalizing more behaviors because of the negative impact on attendees; civil citations can escalate to court appearances and ultimately criminal records. She favors requiring businesses to post "No Loitering" signs that open the door for JSO to go onto private property and deal with crowds. She thinks this bill is an overreach and could be used to chill First Amendment rights and legitimate protests.

Council Member Salem gave several examples of large gatherings that regularly happen in his area and asked how this bill would impact enforcement on those. Assistant Chief Ellis Burns of the Sheriff's Office said enforcement depends heavily on the specific circumstances – public v. private property, owner's permission v. no permission, noise, alcohol, citizen complaints, etc. Council Member Morgan asked about the bill's sunset provision. Cherry Pollock of the General Counsel's Office said it sunsets on December 31, 2021. Ms. Pittman said the bill was filed that way in the expectation that the COVID pandemic would be substantially diminished by then. Council Member Cumber said supports the legislation. She had a situation in her district that pointed out the weakness of the current ordinances and the burden that's placed on neighborhood residents to call JSO to deal with the problems. Council Member Dennis said he does not support the bill because it penalizes the individual attendees at events and because Governor DeSantis has issued an executive order threatening cut-off of state funds to Florida local governments attempting to regulate on the basis of COVID. This bill will disproportionately affect minorities. He offered an amendment to remove the penalty on individuals. Ms. Pollock said the U.S. Centers for Disease Control leaves it to local governments to regulate large gatherings, and she knows that Broward County already does it. She doesn't know if or how the executive order would apply to this bill. Mr. Dennis asked for a legal opinion on how the governor's executive order applies to this ordinance and whether the City might face loss of state funds.

Summary of 2020-529 (Six-Month Window for Normal or Early Retirement):

- 1. Creates new Code Sec. 120.216 providing for a 2021 Limited Retirement Option
- Age 55 with 10 years of credited service (reduced from age 55 with 20 years)
- Age 60 with 5 years of credited service (reduced from age 65 with 5 years)
- Any age with 20 years of credited service, but less than 30 years of credited service, with a reduced accrual rate of 2% (reduced from 25 years of service at any age)
- 2. Police and Fire Pension Fund, Correctional Officer Retirement Plan, and JEA employees are not eligible for this early retirement window
- 3. Establishes a six month early retirement window from 4/1/21 9/30/21
- 4. Requires written or electronic notice of the retirement election and date of retirement to the Board between 4/1/21 5/31/21
- 5. Employees retiring under this option may not come back under full time employment with the City for one year and may not rejoin the DB plan if ever re-employed by the City 6. Allows employees eligible to retire under this option to convert to the Defined Contribution (DC) plan at the actuarial present value of their DB pension
- 7. Provides for an exception to Code Sec. 106.108(c) which requires the affected pension plan to be at least 90% actuarially funded at the time of approval of legislation affecting pension benefits (approval of this exception requires 2/3 vote of Council)

Financial Impact/Discussion Points:

- 1. Based on the October 1, 2019 actuarial valuation, there are 491 participants eligible for early retirement under the proposed options
- 2. The actuarial impact statement shows an increase in the Unfunded Actuarial Accrued Liability (UAAL):
- \$28,740,961 based on 100% take rate
- \$14,370,481 based on 50% take rate
- \$7,185,240 based on 25% take rate
- 3. The actuarial impact statement shows an increase in the annual Employer Contribution:
- \$648,913 based on a 100% take rate
- \$324,457 based on a 50% take rate
- \$162,228 based on a 25% take rate
- 4. The legislation does not reduce the authorized employee cap. The City would incur an increase in the employer contribution to the DC plan (12%) should the positions be filled. If the positions are filled, the employer's DC contribution would increase by:

Public Comment:

Carnell Oliver said public safety has financial impacts; social conditions in the African-American community impact on crime, particularly the lack of positive male role models. The City needs to invest in job training programs beyond Career Source, and have more mentoring programs and more vocational training around the city.
