This bill was discussed last on the agenda as a workshop item. CM Dennis explained the legislative history, wherein there used to be two periods of public comment in council meetings (at beginning and end) but it changed to one period at the end of the meeting. CM Dennis said that the process makes it difficult for some members of the public who can't wait until the end, and that the current process makes it so constituents' voices are not being heard enough. CM Dennis' bill would restore the two periods of public comment.

CM Priestly Jackson spoke about a proposed bill by CM Hazouri which would create a time certain public comment time at meetings, with a set time and where there would be a cut off for comment card submissions.

CM DeFoor said she supports one period at the beginning, as did CM Carlucci. CM Boylan suggested that the period be placed ahead of the consent agenda.

CM Dennis said he would prefer to defer the bill to wait to see the outcome with a bill CM Salem is working on, which would change the City re-naming process to add more public input. CM Dennis questioned why just re-naming would call for more public input, and not all bills including economic incentive agreements with developers.

CM Priestly Jackson mentioned the merit to hearing public comment prior to taking action on bills, and said the committee will revisit this topic at the next workshop meeting in September. CM Dennis said that whatever the committee eventually agrees upon could be a Rules Committee substitute on the bill.
