CM Ferraro said he believes that what the NEFRC does is a duplication of services which are already provided by the city of Jacksonville. Ms. Moehring explained that there value as an organization is the planning and coordination effort to connect counties in Northeast Florida. John Pappas, Public Works, explained the legislation which will raise the host tipping fee by 43 cents a ton. Mr. Pappas said that the capacity at Trail Ridge would not reach capacity for another 25 to 30 years. CM Becton talked about how the tipping fee had not been raised since 2007-2008.

Questions for John Pappas and Brian Hughes

CM Becton asked about yard waste pickup and the impact of waste not being picked up and left in the streets. Brian Hughes said they had met with the haulers last week and emphasized the need for follow through on their commitments to pickup. Mr. Hughes said that the fall months will statistically be lighter in terms of yard waste. Mr. Hughes talked about what they are doing to get more drivers on the road and taking CDL drivers from other areas and using available overtime. Mr. Hughes talked about the work being done to find solutions to this issues. CM DeFoor and CM DeFoor stressed the need for more communication from the administration regarding yard waste pickup. CM Ferraro said he believes there should be more locations and transfer stations. CM Cumber emphasized the need for more messaging in order to get the word out for both hauler positions and the issues that are currently going on with staffing.
