Department of Health Presentation

The Florida Department of Health in Duval gave an update on covid-19 cases and vaccines. Dr. Chowdry Bari said that cases have been going down and for the week of September 24th to 30th there were 1,436 cases with a positive rate of 7.3%. Dr. Bari said that 62% of Duval County residents are fully vaccinated and 16.2% of those ages 12 to 18 are vaccinated. Kyda Hancock detailed the homebound testing process and the criteria needed for having the booster shot from Pfizer. CM Salem asked for the number of covid-19 deaths. Dr. Bari said as of September 29th there have been 3,016 deaths due to covid-19 in Duval County.

Brian Hughes, Chief Administrative Officer, detailed the work that has been done at the Regeneron antibody therapy site at the library.

Phillip Peterson, Auditor's Office, explained the Auditor's handout. Lori Boyer, DIA, detailed the historical background to the project and gave an overview of the project. Brian Hughes said the administration is in support of this plan. Mark Lamping, Jacksonville Jaguars, talked about the process they have gone through over the past 4 months to make it to this point. Paul Harden discussed the amendments. The recommended amendments and DIA/Developer amendments

were passes. The first recommended auditor's amendment was passed, but the second recommended amendment failed to pass and both Ms. Boyer and Mr. Harden voiced their opposition to the amendment.
