Department of Health - COVID Update

Brian Hughes, Chief Administrative Officer, said that there may be upcoming legislation for funding to expand the Telescope Health testing site. Mr. Hughes talked about the new location for the Regeneron clinic and that the occupancy in the hospitals is currently around 80%.

Dr. Bari, Health Department, gave an update on the rise of covid-19 in Duval County. There have been more than 1,000 cases a day and Duval County is now considered a high transmission county by the CDC. As of December 25th, there have been 3,347 deaths in Duval County from covid-19. Dr. Bari said that delta is still the major variant of covid-19, but omnicron is surging. CM Priestly Jackson asked for clarity on the vaccination numbers. The 62% vaccinated statistic for Duval County covers people that have partial or full vaccination status.

• Presentation by Daryl Joseph, Parks Department, on Military and Veterans' Appreciation Program at Hanna and Huguenot Parks

Daryl Joseph, Parks Department, gave a presentation on the Military & Veterans Appreciation Program. Mr. Joseph said that military and veteran entry made up 1.5% of Hanna Park and 2.3% of Huguenot Park attendance. The committee said they would move forward legislation to make this discount permanent.
