Emergency Rental Assistance Program Update

Deputy CAO Stephanie Burch gave the update on the ERAP program. ERAP 1 is in the final accounting stage and the remaining \$413,000 will be transferred to ERAP 2 for distribution as additional rental assistance. ERAP 2: 3,833 households assisted with rent totaling \$20.384,683; 1,109 households assisted with utilities totaling \$730,703; 795 households assisted with mortgage payments totaling \$3,088,354. Approximately \$4,345,794 remains to be distributed for rent and utility assistance and \$920,000 for mortgage assistance. In response to a question from CM Pittman, Ms. Burch said all funds should be expended by the end of March. The application portal has been closed and the system is processing pending applications. The committee thanked Ms. Burch for her good work with the ERAP program and congratulated her on her career with the City as she moves to a new job.

Cure Violence Update - Kendra Mervin

Kendra Mervin, Office of Grants and Contract Compliance, gave an update on the progress of the Cure Violence initiative. The program started in February of 2019 with two sites in Northwest Jacksonville and the Eastside. One additional site has been added on the Westside. Data analysis shows that the program interventions are being effective in reducing the number of shootings in most areas. Lack of staff at one of the providers hampered success in the Eastside area. Next steps include increased focus on high-risk clients, micro-targeting of hot spots, and improved data reporting in conjunction with the program's research partner. A Violence Reduction Center has been established.

Council Member Freeman said the program looks good on paper, but he doesn't feel like he is getting enough information from the program operators to be able to defend the program to his constituents. He asked about the presence of other violence disruption programs in these areas and whether the data presented can be attributed to the actions of one program versus another. Chief Administrative Officer Brian Hughes said his staff will immediately make arrangements for Mr. Freeman to meet with the program operators he wants to meet and get the information he needs. Council Member Pittman praised the program and said that while it is effective, better access to jobs and housing are needed to really make a positive change in community conditions. She wants residents in the community to have a bigger voice in what's going on with the Cure Violence program. Council Member Boylan said that the whole community needs to understand the nature of the city's violence problem and urged Ms. Mervin to go out to community groups (such as Rotary Clubs) citywide to spread understanding of the problem and the solutions. Chairman Salem praised the quality of the data collection and urged that it continue. Council Member Carlucci advocated for additional funding for the Kids Hope Alliance and Public Service Grants to leverage more programming to meet all of the community's many needs.

City Council Budget Priorities

Chairman Salem said that the distributed list includes the recommendation from the last meeting to move up item #4 – focus efforts on after-school and summer programming at \$3M - from the 3-year priority list to the 1-year list. Assistant General Counsel Paige Johnston said the dollar amount for item #5 – increase funding for Public Service Grants - will be updated from \$5.5M to an aspirational \$7M as discussed in a previous meeting. The committee authorized introduction of the legislation.
