11. Coal Ash Resolution

Lisa Rinamin, St. John's River Keeper

Mr. Hardesty detailed the process of unloading coal ash. Ellen Glasser, Mayor of Atlantic Beach, expressed her support for a resolution against the transportation of coal ash in Jacksonville ports. Nick Primrose, JaxPort, said that 21 ISO containers have been shipped through JaxPort, and by law coal ash is deemed non-hazardous so it does not have to be listed. Mr. Primrose said that JaxPort has put out a memorandum stating that they do not support the movement of coal ash. Whitney Croxton, Propeller Club, said that the members of the club are against this resolution. Nicole de Venoge, Surfrider Foundation, talked about the need for clean water and the impact the spill of coal ash had in Georgia. Lisa Rinaman, St. Johns Riverkeeper, asked where FDEP is in this conversation. CM Boylan said the focus should be on the EPA and getting it designated as a toxic substance in order for their to be change. Mr. Barker talked about the need for a comprehensive approach since the emergency response during the spill was also very bad. Ms. Haskell said it is important to find a solution and not focus on a ban of coal ash. Mr. Birtalan said he has concerns about the resolution not digging into the real issues around spills and environmental safety. Mr. Hoyles said it is safer to have coal ash in Florida then in Puerto Rico, because we are able to safely store it. Mr. Adkison worried this resolution is a knee jerk reaction when there are many other toxic substances being transported and spilling into the waterways. Mr. Devereaux said he is against the resolution and stressed the need to focus on oversight. Mr. Baker suggested making a subcommittee on this topic. Chair Ferraro said a public noticed meeting should be set up for January to focus on this topic.
