#### Florida Department of Health in Duval County Presentation

Tawanda Washington and Dr. Chowdhury Bari, with the Florida Department of Health in Duval County said that COVID response is in the ongoing maintenance mode. Response to the monkeypox outbreak is also ongoing. Dr. Bari said Jacksonville is ranked as a low level community for COVID, seeing about 50 cases per day. Monkeypox appeared in June 2022 and Jacksonville has been in a downward trend since August. The department sees a few cases every week – 63 total cases have been identified, mostly in HIV-positive men. The Health Department is using education, community outreach, and partnerships with the City and local hospitals on information and treatment. There are vaccines available for COVID, monkeypox, meningococcal disease and hepatitis A.

CM Salem said that some neighborhoods with strict covenants and deed restrictions prohibit accessory structures; he's worried that some people may start building without knowing that it's not permitted in their neighborhood and that could lead to time consuming and expensive lawsuits. He would like to see a few pilot projects first to see how it works before going countywide. CM Diamond explained the purpose of the bill to help address the affordable housing crisis. The Planning Department suggested accessory dwellings as a possible immediate step that could help. He emphasized that these accessory dwellings can't be larger than one-quarter the size of the primary dwelling unit or 750 square feet and the City can't override private party deed restrictions and covenants. Increasing the number of available dwelling units will help lower the overall cost of housing for everyone.

Bill Killingsworth, Director of Planning and Development, explained the need for the amendment to the Comprehensive Plan to address an existing condition regarding calculation of density in neighborhoods where accessory dwelling units are currently permitted. CM Ferraro raised issues concerning family compounds on large parcels and parking impacts from additional residents in neighborhoods. Mr. Killingsworth noted that setback requirements, on-street and yard parking restrictions, etc. already exist and would apply to these new structures. In response to a question from CM Gaffney, Mr. Killingsworth said that communities without deed restrictions could prohibit these accessory dwelling units by getting a zoning overlay adopted. CM Salem pointed out the difference between deed restrictions and enforcement powers. CM Ferraro suggested adopting overlays just for the areas where the residents want ADU's, not countywide in areas where they're not wanted. There's no control over who will live in them and that's where problems start. Mr. Killingsworth said that accessory dwellings must be on homesteaded lots and if the property is subsequently sold and not homesteaded, then the accessory dwelling becomes a zoning violation if rented for residential use.

Mary Staffopoulos of the General Counsel's Office explained an amendment offered by CM Diamond regarding the requirement that the property must have a homestead exemption and a requirement for physical separation of the 2 structures. Ms. Staffopoulos also discussed a suggested requirement to attach the ADU to central water and sewer service where that is available or to a well and septic system in rural residential and agricultural zones areas where they are approved by the Health Department. CM Boylan advocated for the bill as one way of addressing the affordable housing and homelessness crisis the city is facing. The city has got to come to grips with increasing residential density and get away from the "NIMBY" attitude that shuns higher-density housing. CM Salem said he is opposed because of the possibility of unforeseen long-term negative consequences. In response to a question from CM Clark-Murray, Mr. Killingsworth described the permitting requirements by the Health Department for septic tanks on various sizes of lots. CM DeFoor asked for clarification about the application of this ordinance to short-term rentals (e.g. AirBnB); Mr. Killingsworth stated that short-term rentals in residential districts continue to be illegal in Jacksonville.

Phillip Peterson explained the amendment. CM Salem asked why this grant wasn't budgeted during the just-completed budget process; Mr. Peterson said that often grants aren't finalized before the budget process is completed so additional appropriations are required via stand-alone legislation. In response to a question from CM Ferraro, Daryl Joseph, Director of Parks, Recreation and Community Services, said the vast majority of senior centers have food service capacity but a few do not. Mr. Ferraro said he has heard from seniors that they would appreciate more opportunities for events that serve food (i.e. senior prom dances).

Phillip Peterson explained the amendment and distributed a chart of future DIA funding commitments to projects. CM Salem announced that he would be abstaining from the vote because he has a financial connection with the project developer. Chairwoman DeFoor asked why the funds are being requested from General Fund/GSD fund balance rather than being budgeted in the annual budget. Steve Kelly of the DIA said that DIA requests funding when an approved project has gotten to the point of nearing completion and therefor payout of the incentive. All DIA incentive grants are approved subject to future appropriation of the necessary funding by City Council. Mr. Peterson explained that the chart he distributed shows all of the future DIA incentive commitments which could be appropriated in the annual budget ordinance. DIA has chosen to seek appropriations on a case-by-case basis.

CM Salem noted that the City has already committed to substantial future incentives both in the DIA and in other projects. CFO Joey Greive said the Finance Department tracks these future commitments and considers them as investments in the city's future. He noted that the administration has very substantially enhanced the City's reserve accounts at the same time it has been investing heavily in community improvement projects and they are well aware of what is coming in future years. They prefer to keep the funds in unassigned reserve accounts rather than earmarking them in project-specific accounts.

Phillip Peterson explained the amendment. Kirk Wendland of the Office of Economic Development described the affordable housing project and the City's incentive via a balloon payment loan. CM Salem announced that he will be voting against the project based on the negative traffic impact he anticipates in a very constricted area at Merrill Road and I-295. Mr. Wendland noted that the project is subject to companion zoning ordinance 2022-713 which will require a traffic study for the project. CM Boylan said the Council needs to be supportive of this type of project which will provide much-needed affordable housing. Ms. Staffopoulos cautioned the committee members about taking a position on the quasi-judicial aspects of the project contained in 2022-713 until the LUZ Committee meeting and the appropriate public hearings are conducted.
