Phillip Peterson, Auditor's Office, explained the proposed technical amendments and the Auditor's additional recommended amendments. CM Cumber expressed concerns with incentivizing the developer's construction of a "bare minimum" project by including language that allows the developer to build a project that is less than the highest quality. SM Salem said that concern should be addressed through the Public Works Department's or Park, Recreation and Community Services Department's review of the proposed plans to ensure a quality project will be constructed. CM Ferraro expressed concerns that the project will end up looking the same as what has been designed. Many of the Council Members said their constituents don't believe there will be a Four Seasons constructed at this site and highlighted the "equivalent flag" language. Paul Harden, counsel for the developer, emphasized and confirmed that a Four Seasons hotel will be built in this development. Mary Staffopoulos, OGC, restated the revisions to be included in the Committee amendment for item 5.o. to clarify that the sliding-scale clawback on the Completion Grant will be applicable if the hotel is not operated as a Four Seasons or a brand that is the result of a global change to the Four Seasons name. Lori Boyer, DIA, addressed the Committee regarding additional amendment items that will be brought forward for consideration by the Finance Committee, including an item that addresses the developer's inability to obtain Builder's Risk insurance for the marine improvements which is a nationwide issue.

Phillip Peterson, Auditor's Office, explained the amendment. Brian Hughes, Chief Administrative Officer, explained the legislation and the Mayor's reasoning for why this matter should be forwarded to the voters to decide through a straw ballot. Jerry Holland, Property Appraiser, expressed his opposition to the legislation and explained why he feels this bill will create issues with quorum and have a financial impact.

CM Cumber asked why this legislation only covers certain elected officials. Mr. Hughes said it is because these are the local officials under the City's purview. CM Salem stated he opposes the legislation due to the implications it can have on the City Council. CM Ferraro stated he is against the legislation and called it an act of political maneuvering.

Paul Barrett, Finance Department, explained the legislation. Eric Green, JAXPORT CEO, clarified that all cost overruns will be paid by JAXPORT. Beth McCague, JAXPORT CFO, went over the design process and the time frame of the project. CM Ferraro voiced his concerns about the power lines. Kurt Wilson, JEA, said he will keep all Council Members well informed with what is happening with the project.

APPROVE

- Authorizes support to JAXPORT for the raising of the Fulton Cut Powerlines to increase the number and capacity of vessels able to call on JAXPORT ports by:
- Loaning \$12.5 million with a 10-year term at a 3.5% interest rate
- Providing a \$5 million revolving line of credit at rate equal to City's commercial paper rate
- Approving a \$10 million grant subject to future Council appropriation
- The estimated cost of the project is \$42.5 to \$45 million, with JPA securing a multi-year commitment from FDOT in an amount up to \$22.5 million
