On June 1, 2023 the General Counsel submitted notice of the Federal District Court’s acceptance of the redistricting settlement to the Council Secretary which was included in the Miscellaneous Communications on the agenda of the June 13, 2023 City Council meeting. On May 9, 2023 the Council enacted Ordinance 2023-281-E settling the Jacksonville Branch of the NAACP, et. al. v. City of Jacksonville litigation (Case #3:22-cv-493-MMH-LLL) and adopting the revised maps, which are the same as the court-ordered plan. The legislation had a prospective effective date triggered by the Federal Court’s approval noted in the Miscellaneous Communication of June 13th. The 2023 election for City Council members was based on the Plaintiffs’ 3 Map as ordered by the Federal District Court Judge in December 2022. The General Counsel’s Miscellaneous Communication informs the Council and the public of the court’s approval of the settlement and begins the post-enactment procedures required to be undertaken by the Council staff by Chapters 124.02, 124.03, and 1001.36, Florida Statutes.
