(DVI) for Continued Operation of the Homeward Bound Prog, in Accordance with Sec 932.7055, F.S.; Amend the 25-29 5-Yr CIP Appvd by Ord 2024-505-E to Reflect the Reallocation of Funds; Invoking the Exemption in Sec 126.108(g) (Exemptions From Competitive Solicitation), Pt 1 (General Regulations; Ethics And Transparency in Public Contracting), Ch 126 (Procurement Code), Ord Code, to Allow for A Direct Contract with Downtown Vision Alliance, Inc. for the Prog; Waiving 118.107 (Nonprofits To Receive Funding Through A Competitive Evaluated Award Process), Pt 1 (General Provisions), Ch 118 (City Grants), Ord Code, to Allow for a Direct Contract with Downtown Vision Alliance, Inc. for the Prog; Apv & Auth the Mayor, or Her Designee, & Corp Sec to Execute & Deliver on Behalf of the City that Certain Misc Appropriations Agrmnt btwn the City & Downtown Vision Alliance, Inc.
